

RLS TSCA Statement

Toxic Substances Control Act (TSCA) is USA legislation, prepared by Environmental Protection Agency (EPA). It is addressing the production, importation, use, and disposal of specific chemicals that are imposing unreasonable risk to the health or environment.

RLS products are not chemical substances. RLS products are manufactured from standard electronic components with optional aluminum, steel or zinc housing. No component or material is used in non-standard way.

RLS is not producing or buying any of the listed substances.

RLS is not using any of the listed substances in products or in production processes.

RLS is not requiring any use of the listed substances from suppliers.

We have gathered information on materials used in the RLS products and listed all materials with affected TSCA status in Table 1 below. These articles are currently irreplaceable.

Therefore, we declare RLS products are not imposing unreasonable risk to the health or environment when used as intended and properly disposed of.

RLS is committed to managing the use of chemical substances in accordance with governmental regulations, industry standards, and customer-specific requirements to ensure that all aspects of our business have the least harmful effect on the environment. Consistent with industry practices, RLS does not support analytical testing for toxic substances.
